A description of how the funds will be used to increase or improve services for Unduplicted pupils to improve A-G eligibility

The A-G Access Grant will provide for additional PD for teachers, counselors and administrators to learn and understand best practices to support Unduplicated pupils in enrolling in and succeeding in A-G coursework. Enrollment in Algebra 2, 2nd Year LOTE, and success in all A-G courses will be the focus.

The A-G Access Grant will provide additional hours in Middle School and High School to allow counselors to meet individually with Unduplicated students to develop and monitor a 6-year A-G/college-going plan.

The A-G Access Grant will provide additional hours to allow high schools to provide academic support to Unduplicated students in A-G coursework.

ARP funds provide summer accelerated learning opportunities for middle school and high school students in mathematics through the summer of 2024. The A-G Access Grant will allow the continuance of summer accelerated learning in math for an additional year, through the summer of 2025.

The A-G Access Grant will provide Advanced Placement Exam Fees for Low Income, Foster Youth, and Homeless students to eliminate the financial barrier to taking Advanced Placement Exams.

The A-G Access Grant will provide for a post-secondary tracking services to gather data on the pathways students take after graduation, rather than on self-reported student data.

A description of the extent to which all students, including Unduplicated pupils, will have access to A-G approved courses

Through the district's long-standing Open Access policy, all students have access to all A-G courses. The additional advising, planning, and academic support the grant provides will increase the rate at which Unduplicated students enroll in and successfully complete A-G and Advanced Placement coursework.

The number of students who were identified for opportunities to retate A-G approved courses in which they received a D, F or NM grade in the spring of 2020 or the 20-21 school year, and a description of the method used to offer the opportunity to retake courses

Approximately 3000 students were identified for credit recover in the spring of 2020 and the 2020-21 school year. All students were provided blended credit recovery opportunities (teacher-led synchronous and asynchronous instruction) in the Summer of 2020, Fall of 2020, Spring of 2021, Fall of 2021, and the Spring of 2022.

A description of how the plan and described services supplement but do not supplant services in the LCAP and the ARP

Credit recovery for Unduplicated pupils is a continuing action in the LCAP. Due to increased need brought on by the pandemic, additional funding was provided for credit recovery via ARP grants for the 21-22 and 22-23 school years. The A-G Learning Loss Mitigation Grant will provide for additional credit recovery opportunities beginning in 23-24, after ARP funds have expired. All other actions in the A-G Completion Grant Plan are new actions or continuing actions that extend expiring ARP supports.

- (d) (1) A–G Access Grants and A–G Success Grants shall be used for activities that directly support pupil access to, and successful completion of, the A–G course requirements. Eligible activities may include, but are not limited to, any of the following:
- (A) Providing teachers, administrators, and counselors with professional development opportunities to improve the local educational agency's A–G completion rate.
- (B) Developing comprehensive advising plans and pupil supports, including tutoring programs, to improve the local educational agency's A–G completion rate.
- (C) Expanding access to coursework or other opportunities to satisfy A–G course requirements to all pupils, including, but not necessarily limited to, unduplicated pupils. These opportunities may include, but shall not be limited to, course development, course review, incorporating A–G course requirements into the local educational agency's graduation requirements, and new or expanded partnerships with other secondary or postsecondary educational institutions.
- (D) Advanced Placement and International Baccalaureate fees for unduplicated pupils.
- (2) The Legislature encourages local educational agencies to direct A–G Success Grant funds towards pupils in danger of not achieving a grade of "C" or better in A–G courses.

A-G Learning Loss Mitigation

- (2) (A) (i) A–G Learning Loss Mitigation Grants shall be used to allow pupils who receive a grade of "D," "F," or "Fail" in an A–G approved course in the spring semester of 2020 or the 2020–21 school year to retake those A–G courses.
- (ii) The method of offering pupils the opportunity to retake courses provided in clause (i) shall be determined by the local educational agency.
- (B) If sufficient funds are available after implementing subparagraph (A), a local educational agency may also use grant funds to offer credit recovery opportunities to all pupils to ensure pupils are able to graduate high school on time.
